1. That the batsman shall always bat from the road end (Carter Road) and hit the ball [East] towards the woods.
2. That if there are any claims for damages, and/or injuries to the general public using the park from getting hit by the official leather ball, they will immediately switch to the weighted tennis ball.
3. If there are any damage caused to any motor vehicles parked or using the parking lot the organization will provide and install protective netting at

agreed upon locations.

4. Organization will be responsible for any and all maintenance of their bowling area, while county parks will continue to mow and maintain the natural grass area.

The PERMITTEE shall protect, save harmless, indemnify and defend, at its own expense, Snohomish County, its elected and appointed officials, officers, employees, and agents from any loss or claim for damages of any nature whatsoever, arising out of or suffered, directly, or indirectly, in connection with this license or use of the premises, including claims by PERMITTEE's employees or third parties, except for those damages solely caused by the negligence or willful misconduct of Snohomish County, its elected and appointed officials, officers, employees or agents.
