_____ I am aware alcohol is not allowed in the City of Sammamish parks and shelters. Alcohol is only permitted in indoor facilities with staff approval, event insurance, and a banquet permit.

_____ I am aware that dunk tanks, hot air balloons and remote control airplanes or vehicles are not allowed in the area I have requested.

_____ I realize that I am responsible for my own set-up and clean-up. My reserved time includes sufficient time for both these activities .

_____ I have seen the area or picnic shelter that I am renting and am familiar with its overall condition. I am aware that due to the effects of rain and wind, other park patrons, and the presence of the natural park residents, the outdoor facilities may not be as clean when I arrive as when the routine maintenance was completed.

_____ If permit and payment are not submitted by the date due, it will result in the cancellation of reservation. If the event plans change, I am responsible to contact the City a minimum of 15 working days prior to the reservation date that I have requested.

_____ I am aware that any activities requiring set-up of special equipment must be approved in advance.

_____ The use fee is charged for reserving the described site. It is not a general park admission fee.
