Renter agrees that this obligation to indemnify, defend, and hold harmless in full applies regardless of whether any intentional or negligent act of the City caused or contributed to any such claim, loss, or liability, provided, that Renter shall not be obligated to indemnify, defend, and hold the City harmless from any claim, loss, or liability arising out of the City's sole negligence or sole intentional conduct. In order to provide a full and complete indemnity to the City, but only to such extent, Renter agrees that its obligation to indemnify, defend, and hold harmless extends to claims brought by Renter's own employees from which Renter would otherwise be immune under Title 51 RCW and Renter hereby waives its immunity under said statute to the extent, but only to the extent, necessary to provide the required indemnity. This waiver has been mutually negotiated by the parties and Renter acknowledges that the City would not enter into this agreement without such indemnity.
